I.

The name of this corporation is Selma Cross Cultural Nonviolence & Performing Arts Academy.

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public and charitable purposes.

The specific purpose of this corporation is to promote, preserve, and perpetuate for the benefit of children in Selma and Dallas County, Alabama the following: (1) A Performing Arts Academy;(2) September 16 as The Colia Liddell Lafayette Clark Freedom Day;(3) October 7 as the Worth Long Freedom Holiday; and (4) an Annual Relay Race from Montgomery Alabama to Selma, with copies of the United States Constitution as the Baton, promoting themes such as "The Right to Vote", "Non-Violence", and "Stand up for Constitutional Rights", etc.; and to carry on other charitable and educational activities associated with this goal as allowed by law.
